I. Call to Order

The meeting was called to order by the Chair of the Faculty Assembly, Dr. Barbara Bass (Vice President for Health Affairs, Dean, School of Medicine and Health Sciences, and Chief Executive Officer, Medical Faculty Associates), at 5:07 pm.

A quorum of 50 faculty members was established. This number met the requirements for conducting Assembly business (25) and for approving changes to the Bylaws (50).

The new rule, authorizing virtual meetings of the Faculty Assembly, pursuant to the Guidance published by the Provost in March 2020 regarding online meetings, and passed by the Executive Committee on April 28, 2020, was read into the record. Professor Steve Charnovitz of the School of Law was named Parliamentarian by unanimous consent.

II. Approval of Minutes

The minutes of the March 9, 2020 SMHS Faculty Assembly meeting were unanimously approved.

III. Election of Member of the Executive Committee of the Faculty Assembly. Three-year terms unless noted.

IV. Dean's Report – Barbara Bass, MD

Financial Update:

- University Mitigation
 - The revised budget will be available in April 2020
 - SMHS has an additional burden to address and will work with Budget and Finance Officers, Nancy Rambo and Lance Kaplan to address
 - The deferred separation plan for tenured faculty is still being worked on and will be unveiled in the Spring

Chair Searches:

- The search committee for the permanent chair of the Department of Dermatology has been seated and will begin work soon.
- A search for a new chair of the Department of Orthopaedic Surgery will commence shortly with a call out for nominations from the Office of Faculty Affairs.

Learner Mistreatment:

- Dr. Simons will give a report shortly on the 2020 MD Program graduation survey which includes information on student mistreatment. The SMHS continues to be above the national average in this area and will work diligently to eliminate this problem from its culture. Dean Bass stated that she will take a zero-tolerance stance in this area and hopes that all faculty and staff will take this opportunity to reset our professional standards with all members of our community.

Faculty Awards & New Faculty:

- We are pleased to announce that we will be celebrating the various achievements of our faculty with SMHS Awards Week to be held from November 16th to the 20th. Faculty should have received a request

for nominations, so please submit yourself or your colleagues to be recognized for their outstanding work.

- We also want to welcome all our new faculty members who have joined us since we last met. We are glad to have you all here and hope to be handing out awards to you all in the near future

Other notes:

- Flu shot clinics will be operational soon out of the department of occupational health
- Dr. Nilda Saláman, Assistant Professor of Anesthesiology & Critical Care Medicine passed away on September 17. A communication regarding her memorial will be sent out.

Strategic Plan: Dr. Lawrence Deyton, MD

- Dr. Deyton went over the charge of the five-year strategic plan Drafting Team by Dean Bass; introduced the members of the team; and solicited suggestions, ideas, and other input from the Faculty Assembly.

UHS Security Breach: Dr. Brian Choi, MD

- On 9/27, UHS, the parent company of the hospital was hit with a Day Zero piece of ransomware the mechanisms of which are not yet known or being disclosed. It is the largest cyber-attack on hospital systems across the United States. Every Windows 10 machine was bricked and unable to be used. Such malware is typically delivered by socially engineered email seemingly from someone you know. If it is a known variant, then we have the means to fight it but if it is novel then there is no immediate recourse. In the process of replacing every single computer or have them reimaged, which is complicated due to older machines that weren't running Windows 10. A number of operations have been slowed or still impeded at this time.
- Steps individuals can take to prevent something like this from happening in the future:
 - Don't connect personal devices to the GWU-H network
 - When you receive an email from outside the organization, check that there is a note saying that it comes from outside the organization
 - Use your MFA or GWU-provided email
 - No data was extracted during this attack, but it is still recommended that you change your passwords if the same at the hospital

- Don't click on any links or attachments that seem strange

V. Research Update – Robert Miller, PhD

Dr. Miller gave a presentation (appended) updating the Faculty Assembly on the FY20 research statistics, the research administration, and the strategic plan.

VI. Report on MD Programs Graduation Questionnaire – Richard Simons, MD

Dr. Simons gave a presentation (appended) on the results of the 2020 AAMC Graduation Questionnaire.

VII. Executive Committee Report

The report of the Executive Committee was presented as circulated in advance of the Assembly by Dr. Keith Mortman, Chair of the Executive Committee.

VIII. GWU Faculty Senate Report – Ellen Costello, PhD

- The University Faculty Assembly meeting has been delayed to further explore polling features with the ability to separate voting members from the rest of the general assembly.
- Dr. Costello gave an overview of the resolutions that have gone through the Faculty Senate (a summary is provided in the appended slides) including the resolution to censure President LeBlanc regarding the hiring of Heather Swain
 - Discussion followed on the censure resolution which has been sent back to committee regarding the precedent for such a resolution given that university presidents make poor hiring decision all the time.
 - Considering our current environment with the “MeToo” and “Black Lives Matter” movements, etc. this particular hiring garnered a lot of local and national press. And the fact that the President cannot provide satisfactory answers to questions from the Senate committee due to legal constraints also contributes to the heightened tensions.
- An update on COVID-19 Campus testing was also provided. As of October 1st:
 - 15,146 tests administered
 - 22+ cases

- 7-day rolling average

IX. New Business

No new business was brought before the Assembly.

The meeting was adjourned at approximately 6:30 pm.

- Response rate impacted by COVID-19
 - 149 students responded out of 171= 87.1%
 - 158 students responded out of 164= 96.3% in 2019

Academics: Basic Science – Clinical Relevance

- Similar to last year, most GW students felt that basic science courses had “sufficient illustrations of clinical relevance”
 - **79.8%** vs **75.7%** nationally; and
 - **85.8 %** of our students felt that “required clinical experiences integrated basic science content” compared to **80%** of students at all schools

Academics: Basic science preparation for clerkships

- Biostats, Histology, ICM, Micro, Neuroscience, and Pathophysiology were comparable to other medical schools (within 3%)
- **Biochemistry, Genetics, Immunology and Behavioral Science** rated higher when compared to all schools
- **Anatomy (81.7% vs 86.3%) Pathology (77.4% vs 83.9%), Pharmacology (75.4% vs 80%), Physiology (85.6% vs 89.7%)** rated lower compared to other medical schools

- **Biochemistry** was well above nat'l avg (**75.3%** to **63.1%**)
- **Immunology** was above nat'l avg (**85.6%** vs 80.7%)

Academics: Quality of Clinical Clerkships

- **Pediatrics (95.2% vs 87.3%)** rated significantly higher than the national mean
- **Internal Medicine, Neurology, and Psychiatry** rated favorably/higher to other schools with **Emergency Med** comparable to other schools.
- **Family Medicine (75.4% vs 85.3%), Ob/Gyn (74.2% vs 78.6) and Surgery (70.8% vs 81.9%)** rated lower than the national mean

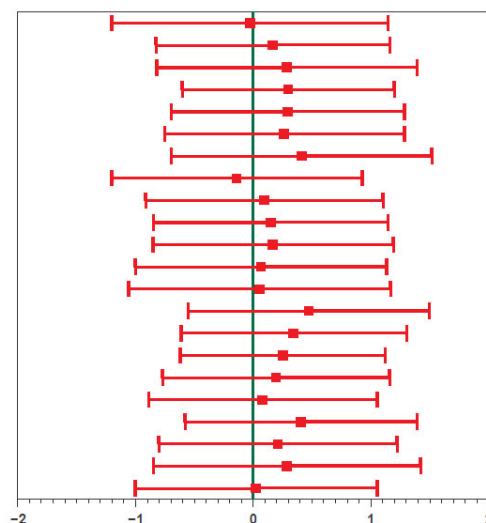

- Similar to last year, **97.8%** of GW students aware of policies (97.6% nat'l avg.);
- **97.1%** of GW students know procedures for reporting (89.5% at all schools)
- **43.4% of GW** students report being mistreated (excluding publicly embarrassed) vs. 39.6% at other schools-(down from last year 46.5%, but still above nat'l avg.)
- **24.3%** of GW students report being publically embarrassed compared to 21.2% at other schools (down from last year 31.2% but still above nat'l avg)

Financing/Medical School Debt

- Median medical school debt:
GW - \$264,000 All Schools - \$200,000 (much higher than last year at \$200K). (actual median debt was \$211K)
- - Median GW scholarship was \$54.5K vs \$25K at other schools (among students with scholarships)

My take . . .

1. Overall, 2020 GW continues to show lower satisfaction with the quality of education than all schools (similar to 2019).
2. Recommended changes to pre-clinical curriculum delayed due to COVID-19. While many improvements were noted, certain disciplines (Anatomy, Path, Pharm and Physiology) – need more work. Recent phase 1 internal survey shows positive trend!
3. Three clerkships ranked lower than national mean (Family Medicine, Ob-Gyn, Surgery). On-going effort to find alternate sites to address capacity.
4. Key student support services in tutoring, academic advising etc need improvement. Comprehensive student survey scheduled for 2021.
5. Learning environment showed some improvement, still not at nat'l avg. More work to be done. We need everyone's attention to this issue!
